Wildfire Adapted Partnership began in 2003 as FireWise of Southwest Colorado after the Missionary Ridge Fire burned 70,000 acres north of Durango and Bayfield. While the name changed in 2018, we are the same organization, and our mission, programs, and partnerships remain aligned with our original goals.

Wildfire Adapted Partnership is a grassroots 501(c)(3) non-profit organization that inspires, motivates, educates and serves individuals, organizations and communities joining together to protect lives and property from wildfire. We have wildfire education and mitigation programs serving Archuleta, Dolores, La Plata, Montezuma and San Juan counties. WAP also produces and distributes literature and hosts educational programs and events to help residents learn to live safely with wildfire.

NEIGHBORHOOD AMBASSADOR PROGRAM

The Neighborhood Ambassador Program is the backbone of our organization. Volunteer ambassadors serve as catalysts within their communities, encouraging their neighborhoods to become aware, active, and prepared for wildfires. Ambassadors receive training, ongoing education, access to wildfire information experts, and support to plan and accomplish wildfire risk reduction projects. We foster close relationships with our ambassadors and work together to enhance our presence in the wider community through educational events and public service activities.

INCENTIVE PROGRAMS

CHIPPER RENTAL REBATES

Created in 2013 as a response to a need for reducing slash piles from hazardous fuels reduction projects, residents or HOAs that perform mitigation on their property are eligible to receive a partial reimbursement of expenses for having slash ground into chips.



SITE VISITS AND DEFENSIBLE SPACE COST SHARE

A Home Ignition Zone (HIZ) Specialist (Wildfire Adapted County Coordinator) performs a thorough assessment to identify home ignition zone risk factors, including structure ignition potential from embers and hazardous vegetation, and discuss solutions to mitigate these threats. Homeowners who choose to move forward with mitigation receive a full scope of work and resources to obtain bids from local contractors. Wildfire Adapted Partnership can reimburse homeowners up to 50% of these mitigation expenses.

COMMUNITY WILDFIRE RISK ASSESSMENTS

Community Assessments were created as a way for communities that did not have the resources or need to complete a full Community Wildfire Protection Plan (CWPP) to create a wildfire mitigation plan. Community Assessments can provide the background information for a more in-depth CWPP in the future, if necessary. To initiate an assessment, Wildfire Adapted Partnership, the local fire protection district, and our partners conduct a walk-through of the neighborhood. The community receives a written wildfire risk assessment report, complete with pictures, and recommendations to get the community started on their wildfire preparedness efforts.

BENEFITS OF MITIGATION

In 2018, when the 416 Fire raged north of Durango, scorching tens of thousands of acres, the Falls Creek Ranch neighborhood was ready. The community knew it was located in the WUI (wildland-urban interface), and prepared for the worst through several years of fire mitigation efforts such as clearing brush and overly dense trees, led by a Neighborhood Ambassador and guided by a Community Wildfire Protection Plan. As a result of the neighborhood's hard work, firefighters could focus on getting hoses and sprinklers in place to combat the eventual arrival of the fire. No structures were lost; instead, the fire was diverted into wildlands, where it could burn without impacting built environments.
